***Defiance County First Families***

If you can prove your ancestor resided in Defiance County before January 1846, your ancestor will be classified as a "Pioneer." If he or she lived here between January 1846 and December 1860, that ancestor will be classified as a "settler."



To prove your lineage back to your ancestor, you may use birth records, death records, marriage licenses, census records, Bible records, and other primary or supportive secondary records.

The application fee is \$15.00 which covers as many ancestors as you can prove and also covers your membership pin. You must be a member of the Defiance County Chapter OGS to apply. This membership may be paid at the same time as your application fee is paid. The cutoff date is August 1st of the year in which you apply. ## **What's Been Happening at DCGS?**

### **April Board Meeting**

At the April board meeting President Brown noted that there were 72 members, and Dianne Kline noted that the blog site had had over 6000 hits.

As a new five-volume set of birth records have been published, the following motion was made. Joanne Allison moved to add another step to the publication printing cost index. For a publication of 201 pages or more, the price will be \$40.00. Lavina Boesling seconded the motion which passed.

The issue of raising membership dues for 2017 was tabled.

The date of October 22 was set for a genealogical help session at the Sherwood Branch Library. Preregistration will be required and well as submitting specific research questions beforehand.

### **April Chapter Meeting**

Since there was no new nor any unfinished business, President Brown introduced the speaker Daniel Schaffer and his assistant Deb Miller representing the Schaffer Funeral Home. Joanne Allison provided the following information from her meeting notes:

"The business was started in the 1850s by the John Conrad Martin family, German immigrants who became undertakers as part of their furniture business on 5th Street.

"In 1911, Charles Mansfield purchased part of the business and changed the name to Mansfield Funeral Home. Then in 1927, the business was moved to its present location with the purchase of the elegant Dietrich house at 529 Jefferson. Mr. Schaffer showed numerous Photos of the beautiful 1850s structure and the additions and renovations over the years.

"Various owners have renamed the funeral home: In 1952 when Willard "Bill" Mast purchased the business, it became Mansfield-Mast Funeral Home. Still remaining in the family but passing on to younger generations, Willard's son, Walter joined the business in 1957; his son-in-law, Marllin "Stub" Mock also entered the

firm in 1958. Therefore, in 1965, the name was changed to Mast & Mock Funeral Home. Since then, because of retirements and other variations in business partnerships, names had been modified as follows: Mast-Mock-Hoffman in 2006, Mast-Mock-Hoffman-Hanenkrath-Clevenger-Schaffer Funeral Home in 2007, and Hanenkrath-Clevenger-Schaffer in 2010.

"Currently, the establishment is under the ownership and direction of Dan Schaffer, and since 2013, it carries the name of Schaffer Funeral Home. Dan and other employees take pride in their history and the fact that, even after 165 years, the home is still locally and independently owned and serving the Defiance area.

Dan Schaffer provided a door prize, won by Bob Zimmerman, consisting of a tote bag full of coffee, cups and other goodies.

Mary Scranton reminded attendees that applications for Defiance County First Families must be received by August 1.

### **May Board Meeting**

The Defiance Public Library did not receive the digitalization grant for which they had applied. They will apply again from the coming year. The board decided to keep the \$1000 in reserve for digitalization at the library until a future date.

Dianne Kline noted the blog site has had over 7000 hits.

President Brown noted that all of the internment records for Memory Gardens are available online. She also noted that Auglaize Village is working toward having a building to house various records.

A work day at the storage facility at the former Legion building was set for June 1 from 9:00 to noon.

### **May Chapter Meeting**

Dianne Kline noted that the revised five-volume set of birth records are now available. (See the article on the following page along with the article highlighting the program presented by Don Allison on the Civil War and Northwestern Ohio which he presented at the May 23rd meeting.)



## **The Civil War and NW Ohio**

**Don Allison, author, historian, and editor of The Bryan Times displays the books he has written about the Civil War. He spoke to DCGS chapter on May 23 about some of the individuals**

**and regiments from NW Ohio involved in the Civil War.**

***The following article was written by DCGS vice-president and public relations representative Joanne Allison. It appeared in The Crescent-News and The Bryan Times.***

Three days after the April 18, 1861, attack on Fort Sumpter, S.C., and Lincoln's call for 75,000 volunteers who were willing to fight to save the Union, the news first reached Bryan by telegraph. Williams County Sheriff James Bell read the news to people in the courthouse. Immediately, enlistment forms were printed, and local men began to volunteer, first forming the 14th Ohio Regiment. This first enlistment was only for 90 days, since everyone believed the fight would be over in that length of time. Volunteers were hailed as heroes as they boarded a train, and cheering crowds gathered at depots all the way to Toledo.

However, the men soon faced the reality of leaky barracks, miserable meals, scanty rations and general camp life. Within a month, the 14th OVI headed south across the Ohio River where they experienced the brutality and ugliness of war. At the end of their 90-day enlistment, the men of the 14th came home, but since the war was not over, most re-enlisted for a term of three years, many into the new 38th Regiment. The 14th OVI continued to fight on the Western Theater, and eventually joined Sherman's

March to the Sea.

Another local Ohio regiment, the 21st, was known for using the new rapid-firing Colt revolving rifles and holding Horseshoe Ridge during the Battle of Chickamauga. One of the most famous soldiers of the 21st was William J. Knight. Originally from Farmer Center, Defiance County, Knight became a citizen of Stryker, Williams County, after the war.

Knight participated in "The Great Locomotive Chase," when he and the Andrews Raiders highjacked a locomotive, wreaking havoc on Confederate railroad tracks, bridges, and telegraph wires around them. The raiders were captured, taken prisoner, and some were hanged.

Knight and seven others escaped. The men eventually received the first Medals of Honor for their brave contribution to the war.

Allison told of the involvement of a few local veterans such as Emerson Opdyke from the 125th and Isaac Sherwood of the 111th Ohio, as well as interesting battles and highlights from other northwest Ohio regiments, such as the 48th and 68th.

However, the regiment most closely associated with northwest Ohio was the 38th, which was organized in Defiance in September of 1861 for a three-year term. To those who re-enlisted before the end of the three years, the government rewarded a one-month furlough at home. While on furlough, the veterans were honored with a silk banner, hand-sewn by the women of Bryan. It was presented to Col. William Choate, who vowed "we will defend it with our lives."

Indeed, several color guards were killed and wounded defending that flag as the 38th continued their fight in the Atlanta campaign and onward to the sea. Col. Choate was mortally wounded at Jonesboro, Ga., as he tried to retrieve the flag, which had fallen to the ground after a color bearer was shot. Eventually, the 38th Ohio flag was returned to Williams County, and it is presently displayed at the Williams County Historical Society museum.

Allison also told about conflicts at home between the Union Army supporters and the anti-war Copperheads. He then concluded the program by answering questions from the audience and offering some of his books for sale.

## **Revised Birth Records Published** ***Over 1100 names added***

A **NEW** five-volume set of Defiance County Birth Records has been completed and is ready for sale. Originally, the birth records (1867 - 1908) were read by Fayne Harter back in the 1970s and the books were produced then.

In the new volumes, we have made corrections where noted, alphabetized correctly, and added over 1100 new birth records discovered at the Defiance County Records Center.

The book will contain Surname, Given Name, Place of Birth (not always Defiance County!), Parents' Names and the Location of the Record. The location might be BR (Birth Records books) or F (File) or C (Case). This location should be mentioned when asking for a record from the Records Center because it is a great finding help to the staff.

Are there still errors? It's very likely. Spelling was often done by phonetics, and we have left the spellings as they were, for the most part. So a researcher must be creative in searching for a name that could be spelled various ways.

It is VERY important that a researcher order the record and make his or her own decisions on transcriptions. It was not easy to decipher some of the handwriting of the day. Someone familiar with the family may be able to make a more correct decision on the information from a record.

The books vary in size, hence the prices vary a little. The price already includes tax and shipping.

The volumes are divided by the first letter of the SURNAME.

## **Proposed Changes to the DCGS Policies and Procedure Manual**

The Policies and Procedure Committee has recommended the following changes.

Under Article III - Governing Board  
Section 1. Tenure and Duties

Add the phrase **"in good standing."** The sentence then would read "The Officers and Trustees who make up the Governing Board of this chapter must be current members in good standing." Also add: **"No officer shall serve more than two consecutive years in the same office unless three-quarters if the members voting in the election approve a further continuation of the officer."**

In this same section, add Letter F. **"Trustees: 1,2,3 or more"**

Under Article V Dues

Add a third paragraph to read

**"Classes of membership and dues**

**1. Individual membership \$12.0**

**2. Family membership \$15.00 (one newsletter per household)**

**3. Libraries - free (if newsletter not mailed)**

**4. Societies and Organizations \$10.00"**

## The 1880 Mortality Schedule--

### *An Alternative 1890 Census Record*

As you may or may not know 1890 census records were lost. The Eleventh United States Census was taken beginning June 2, 1890. The data was tabulated by machine for the first time. Most of the census records were destroyed in a 1921 fire.

To locate an ancestor, a researcher must use other resources. One often used source for men in the 1890 Veterans Census. Another source, close to 1890, is the 1880 Mortality Schedule which details deaths that year by county. It provides the age, sex, birth place, birth places of parents, the month of the death, and the occupation is known.

The following is a partial listing (A- Kibble) from the 1880 Mortality Schedule for Defiance County. The remaining mortality listing will continue in the fall 2016 newsletter.

## **“Old Uniform and Sword of Military Days Retained by Farmer Township Resident “**

*Defiance Democrat*

July 1915

Mrs. **Eleanor F. FOOTE**, daughter of Richard and Harriet KNIGHT (deceased), was born February 15, 1842, in Wayne County and came to Farmer Center in 1850. Her only sister, **Eugenia M. HAYMAKER**, lives in Defiance. Mrs. Foote was married July 17, 1862, to which union two children were born: Richard Elmer and Mrs. **Jennie YEAGLEY**, Farmer. Her father built the first sawmill, and after running same for several years, disposed of it, purchasing the **John RICE** farm. The present home was acquired in 1863. Mr. Knight belonged to the old military company, and Mrs. Foote still has his sword and uniform, both of which have yielded to the merciless exactions of time and usage.

## **“A Brief Sketch of the Life of Aged Resident of Farmer Township”**

August 5, 1915

**Richard RICHARDSON**, son of **Thos. and Elizabeth RICHARDSON**, was born in Tuscarawas County, May 2, 1837. He came with his parents to Defiance County, settling in Farmer Township on Sections 16 and 17. He was married to Margaret A., daughter of **William and Catherine POWELL**, April 7, 1859. The children are: **Clara E. HOOTMAN** of Kalamazoo, Mich.; Frank Watson of Hicksville; William Payson of Port Murray, N. J.; Chas. Vernon of Nashville, Mich.; Stella Belle **FREDERICK** of Tenafly, N. J.; **Eulah Kate McCONKEY** of Alma, Mich.; Richard LeRoy of Butler, Ind.

Mr. Richardson still occupies the old homestead in Farmer Township, but has made his home with his son in Hicksville since the death of his wife in September 1895. He has been a member of the Presbyterian church since nineteen years of age.”

## **“SKETCH OF ‘HAPPY JACK’ – Hicksville Man Who Clangs the Anvil and Gets Music From Its Ring.”**

August 12, 1915

The subject of this sketch and the accompanying cut (photo), **David Miller (Jack) SAUNDERS**, was

born in Lochee, Scotland, July 4th, 1874, and is the son of **James and Grace SAUNDERS**. He has a brother, Thomas, at Waterloo, Iowa, and two sisters in Scotland.

Mr. Saunders emigrated to the United States in August 1888, settling for a time in Massillon, O. His father was a blacksmith; therefore, it came easy for Dave to embrace the same profession. Following this bent, he served a full apprenticeship under **Charles McCURR** at Goshen, Ind., establishing himself at Waterloo in 1895.

He was married to **Manda MILLER** of Elkhart county in 1893, to whom two children were born, Ethel and Clyde. The daughter is at home and the son resides in Elkhart County. Mr. Saunders was again married in 1896 to **Florence MILLER** of Dekalb County. Elwood Mabelle and Grace are the children by this union.

‘Jack’ has been in Hicksville during the past eleven years, and as a blacksmith has but a few peers. In his younger days, he was pretty clever in the art of self-defense. He has also written some clever verses.”

### SOME HISTORY OF THE BEND - Delaware Bend

#### *Defiance Democrat* **May, 1915**

Delaware Bend was established as a station on the B. & O. in 1874, the name being carried until the government changed the name of the post office to simply, The Bend. The change occurred in the early nineties, and was brought about by so much of the mail intended for this office going to Delaware. The railroad was having a similar difficulty in the freight department; therefore the agent, C. E. **STEVENS**, who served thirty years continuously in that office, was instrumental in having the name of the station changed to conform with the name of the post office.

James **FAHEY** was appointed postmaster in 1892, and served continuously, barring a short term, until the office was discontinued on March 1st, 1915. Mr. Fahey

is at the head of an excellent general store and one of Delaware Township's substantial citizens. Another general store is conducted by Fred **BRENO**, an interested member of the Democrat family. Two churches direct the spiritual affairs of the community. Since the discontinuance of the post office, the people get their mail over route 12, Defiance, and route 2, Sherwood.

Mrs. F. J. **LIMBAUGH** has been a reader of the Democrat for thirty-nine years, and is probably just as enthusiastic now in scanning the news columns from week to week as she has ever been. It is quite refreshing to find these patriarchs in the ranks of the Democrat family. 1876 is the first date assigned to the Limbaugh address, and this estimable lady has been a widow for twenty-three years.

Mrs. Mary **SLOUGH** has read the democrat during the past quarter of a century, and seems to appreciate the mission of the paper. She is also a lady having a lively interest in current events and the history of the present.

James **FAHEY**, ex-postmaster, has received the Democrat and the Crescent-News for a long time. He is interested in Defiance County affairs.

This community seems to be deeply interested in the idea of dredging the Maumee River. Some are inclined to think that the bottom lands would be benefitted, while others are in doubt as to the utility of the project. It is even suspected by a few that a deep waterway would restore The Bend to its own in the way of commercial activity.

Theresia **KINCH** was born in Baden, Germany, April 27, 1821, and died at the home of her son, Fred **BRENO**, at The Bend, May 5, 1915, aged 94 years and 8 days. The deceased came to the United States in 1841, several years previous to the coming of her father, Herr Anton **VON PAULE**. The major portion of her life was spent in Ohio, the past twenty-five years being in the home where she died on Wednesday. Two sisters survive, namely Kate **KILLION** of Defiance, five years younger, and Francisca **MUTZ** of New Haven, Indiana, seven years younger.

Five children are left to mourn their loss, as follows: Mrs. Maggie **NAGLE**, Upper Sandusky; J. N. **BRENO**, Kansas City, Mo.; John **BRENO**, Toledo; Fred **BRENO**, The Bend; Geo. **BRENO**, Memphis, Tenn. Her marriage to Mr. **KINCH** occurred about 25 years ago. Burial at St. Stephen's Catholic Church, Saturday morning, May 8th, at nine.

## **Good and Free Genealogy Websites for Beginners**

*These are some of the free websites for beginners (and for those of us who have not tried them!)*

### **1. About.com**

Has dozens of how-to articles on research basics and on online searching, and sharing.. You don't do actual research on this site, but you will gain good "how to" because each article leads to more detailed and related articles on the same site. There are three main topics tabs-- Learn How, Search Online, Share and Preserve.

### **2. Atlas of Historical County Boundaries**

Many genealogical records are created by counties, the boundaries of which may have changed over time. On this site, click a state, then "View Interactive Map", and enter the date for which you want to see county boundaries. You'll be able to identify which county that town was part of during the time your ancestors lived there. Click to add layers showing modern maps so you'll know where it is today.

### **3. BillionGraves.com/Find-a-Grave.com**

Search an enormous GPS-tagged database of tombstone images. Tombstone photos you've taken can also be uploaded. Users can add personal history information to individual photos and link them to other tombstone images.

### **4. Chronicling America**

The Library of Congress' portal to historical newspapers has two important areas of content: digitized newspaper pages (1836-1922) from 25 states and Washington, DC, and an index to all known newspapers published in the United States and where to find them today.

### **5. Cyndi's List**

Here, you will find lists of sites dedicated to researching particular places, types of records, ethnic and religious groups, and more. Check out the Beginner's category for guides and tips just for newbies.

### **6. FamilySearch.org**

This is one of the best free online resources available. Search millions of digitized and indexed records from around the world. Use the Learn tab; it's packed with keyword-searchable articles and online courses. The "Catalog" tab takes you to the most extensive genealogy library catalog in the world. Microfilmed holdings can be rented for use at a FamilySearch Center near

you (see the FamilySearch Centers tab).

### **7. General Land Office Records**

Find many records generated when our ancestors bought land from the federal government, especially in the Midwest and West. Access images of more than 5 million land title records dating back to 1820. Click on the Reference Center for more information about public land sales, patents and survey plats. No state land sales are located here.

### **8. Google**

In addition to the ability to search for names and places, Google offers several genealogy-friendly tools. Google Translate helps you translate text and websites into or out of English. Google Books includes an online library of out-of-print resources such as local histories and compiled genealogies. Google Maps and Google Earth help you locate ancestral addresses.

### **9. HeritageQuestOnline**

Access this resource free if your local library offers it. Just click to search US censuses, Freedman's Bank records for African-American ancestors, Revolutionary War materials, local and family history books, articles and more.

### **10. National Archives Resources for Genealogists**

Here's your portal to the US repository for most federal military, census, immigration and other records. Read excellent descriptions of these record sets and order copies online. Some have been digitized or indexed; click on Online Research Tools, then Access to Archival Databases or Records Digitized by Partners. At the first, find databases to selected records at the National Archives. At the second, find a list (by microfilm number) of records now on Ancestry.com and Fold3.com.

### **11. USGenWeb Project**

Explore a directory to websites containing free genealogical resources for every US state and most counties. Quality, content and design varies from site to site. You'll commonly find what local resources exist and how to access them, along with indexes to cemetery, marriage and other local records. Share your own records on these sites, too.

### **12. Webpages by Stephen P. Morse**

A good site to look for passenger and immigration information. Search tools may take you to other websites. Click on About This Website and How to Use It for a primer, or just scroll down to the various search forms and the accompanying explanations.
