

<u>First Families of Defiance County</u> <u>and Centennial Families</u>

Defiance County First Families

If you can prove your ancestor resided in Defiance County before January 1846, your ancestor will be classified as a "Pioneer." If he or she lived here between January 1846 and December 1860, that ancestor will be classified as a "settler."



To prove your lineage back to your ancestor, you may use birth records, death records, marriage licenses, census records, Bible records, and other primary or supportive secondary records.

The application fee is \$15.00 which covers as many ancestors as you can prove and also covers your membership pin. You must be a members of the Defiance County Chapter OGS. This membership may be paid at the same time as your application fee is paid. The cutoff date is August 1st of the year in which you apply. Defiance County Centennial Families

News of the DCGS

September

Chapter Meeting

The chapter agreed to pay for 75 copies of the program for the dedication of The A. W. King monument to be held October 18.

Tanya Bruner - Speaker

The speaker for the evening was Tanya Bruner of the Office Of Veterans' Affairs. She reminded the group of the Defiance County Veterans Database which now has 44,000 entries. Everyone is encourage to check out the data base which can be found online and enter information for anyone not found there.

Tanya also mentioned the newly published Vietnam 50th Anniversary Memory Book which lists brief biographies of area Vietnam Veterans.

Prisoners of war was the topic of Tanya's presentation. The term is no longer being used; since 2000 "missing captured" is the preferred term. She noted how "rules" for treating prisoners of war have changed throughout history. Tanya then made the connection with prisoners of war and Post Traumatic Stress Syndrome which was just as prevalent, surely, in all wars although not being labeled as such.

Tanya encourage all veterans and friends and family of veterans to contact the Defiance Office of Veterans Affairs for help. Many questions and comments followed her very interesting presentation.

October

Board Meeting - October 22

It was noted that about 30 people were present for the dedication of the A. W. King memorial.

Photographs of the Defiance Post GAR veterans have been given to Dan Hasch to post on the chapter web site. In the chapter blog, Dianne Kline is endeavoring to include brief biographies of the men. Anyone already having biographies should contact her.

It was moved and passed by the board to give Rita Relue a one-year membership in the DCGS in recognition of the many years she served the Defiance Public Library System and provided a strong liaison with our chapter.

DCGS Annual Banquet - October 26

Twenty-three members and guests were in attendance at the chapter annual banquet. Following the dinner, Jessica Marie Peter Timbrook was inducted into the First Families of Defiance County. She was able to identify 15 ancestors who lived in Farmer Township before 1820. The Bigelows were in residence there in the 1840s.

Certificates were presented to Rowena Bayes who nominated two of her Figley ancestors into the chapter's Civil War Honor Roll.

Steve Ball of Columbus, Ohio, both entertained and provided historical background for the songs he sang from the Civil War era.

November

Board Meeting

President Brown noted that there currently are 94 members in our chapter. She also noted that she has not been able to find anyone to serve on a nominating committee nor run for any office. The current officers agreed to stay on for one more year with the exception of the corresponding secretary. That position is open.

The board clarified that in order to add more names to a First Family membership, the person wishing to add a name needs to be a member of the chapter at the time the name is added. That person, however, will not need to pay the initial initiation fee. This clarification will be added to the Policies and Procedures Manual.

President Brown explained the ramifications of Ohio H. B. 64. This bill would allow for a patron to copy (with a scanner or camera) birth and death records of Ohio City and county records at no cost. Copying in this way avoids the fee for certified copies. One must, though, keep in mind that for many purposes certified copies are required.

Chapter Meeting

President Brown announced that a corresponding secretary is needed for the chapter; however there were no volunteers.


Mary Scranton - Speaker

Sinking of the Sultana - the Great Civil War Disaster



Over 1700 lives were lost in the sinking of the *Sultana*. It is still the worst maritime disaster in American history occurring on April 27, 1865, when the steamship *Sultana* exploded and burned on the Mississippi River.

Soldiers on the Sultana from Defiance Area

From Disaster on the Mississippi by Gene Eric Salecker

On board the *Sultana* were Union troops returning to their homes in Illinois, Indiana, Michigan, Ohio, Pennsylvania, and Tennessee. In addition there were also civilian passengers. Some of the civilians noted were the Sisters of Charity and the Chicago Opera Troupe. Although exact figures vary, there were approximately 2500 passengers on a boat built to carry 376 passengers. More than 1700 perished from the disaster. Two area infantry units were especially hit hard in the disaster.

Corporal Albert W. King's Account of the Disaster

From Salecker's *Disaster of the Mississippi Pages 104,122,125,143,158*

After the explosion, Cpl. Albert W. King of the 100th OVI and his four friends saw "Hundreds of men rushing out [of the stern cargo room] to get breath. "We could not see how many of us could be rescued." Later King would jump into the water to escape the burning ship. As he swam he had to avoid the bodies in the water,

Lt. Harvie Annis and his wife Anna were still sleeping when the explosion tore through the center of

the *Sultana*. Opening the door he ran into a cloud of steam coming from the saloon. Too, the door to the promenade was stuck.

"Lt. Annis took his child and wife through the smoke-filled main cabin to the stern of the boat. He slid down a rope still holding the child and waited for his wife to follow. As she came down the rope, she was knocked down into the smoke-filled hold. After pulling out his wife, they move to the stern's railing. Harvie then jumped with his child, but when Anna hit the water, she discovered that her life belt wasn't fastened correctly. While Anna held onto the rudder fixing the lifebelt, she and her husband were separated. She was forced to leave the rudder from the force of the blazing fire and grabbed onto a piece of floating wood. Albert King had found his own board and went back to help Anna and together they floated away from the burning boat."

Later, Albert W. King and Anna were among the survivors brought to Mound City. Stranded together on a drifting log with water up to their shoulders, they at first were not seen, until Levi G. Morgan of the 21st OVI directed the rescuers to the pair.

King and Anna were taken to a shanty where they were warmed with blankets. Anna was distraught over the loss of her husband and child, but in gratitude for his saving her life, Anna gave Albert a ring. King noted that Anna had given all she could as a reward, as she had lost everything else on the *Sultana*.

<u>John Cornwell and Lewis W. McCrory -</u> <u>Their Accounts of the Sultana Disaster</u>

From Salecker's Disaster of the Mississippi Pages 133-134

"Lewis W. McCrory was swimming along with his pocketbook containing 'over a hundred dollars' gripped between the last two fingers of his right hand and a valise holding 'a good suit of citizen's clothes.' He switched the valise from one hand to the other as either arm grew tired. Swimming side by side with McCory was Sgt. John Cornwell (of Co. A, 100th OVI).

According to Lewis McCory, "After a while Cornwell called out to me that he could hold out no longer, but I cheered him up, urging him to try a little longer,. "He tried awhile longer and then cried out again that it was no use; he must sink." Urging Cornwell to fight on, McCrory wrote, "We had gone about two miles

when he called out a third time and sank immediately, and I saw him no more." McCrory was "startled a little" by Cornwell's death and let go of the waterlogged valise, but he managed to hang onto the pocketbook.

McCrory recalled, "Now what seems strange to me is that in a very short time after throwing away my valise both arms became entirely helpless, and I was obliged to turn over on my back and float in order to rest. After floating awhile I swam a short distance when my arms gave out again." Forced to turn on his back a second time, McCrory repeated his earlier motions until he was lucky enough to spot a log "...upon which I crawled," he remembered, "and where I remained."

Levi G. Morgan's Account

From Salecker's Disaster of the Mississippi Pages 59,123,144,158

In trying to assign blame to the overloading, Pvt. Levi G. Morgan testified that he had overheard the captain of the boat, Captain Mason, expressing his concern that Captain Speed was "...loading the boat and would put as many on as he pleased."

Following the explosion, Pvt. Morgan helped with the wounded. A private named Spafford with the 102nd asked Morgan what he should do. "Taking Spafford in tow, Morgan went over to a pile of debris and pulled out a large plank. He threw the plank into the water and made Spafford jump after it. Morgan then decided that it was time to get off the boat himself.

A good swimmer, Morgan watched for his chance and jumped. He took nothing with him "My only fear was that someone would get hold of me and pull me down," he later wrote. He swam as fast as he could and was able to get through the struggling crowd.

Later, in the growing light of morning, Harrison Spafford and Morgan encountered each other once more. Still holding the plank that Morgan had procured for him, Spafford offered him a free end. Morgan snatched it up. "I was nearly used up," he recalled, "for my legs were badly cramped."

Assisted by the long plank, the two men found a pile of driftwood lodged against a tree. By climbing up on it, they were able to get out of the water. "My first landing place was a tree that protruded from the water," Morgan wrote. "I climbed into the branched of this tree, only to find others of the company there." Feeling a bit

safer, Morgan, Spafford, and the others awaited rescue.

GAR Post in <u>Hicksville Named for</u> <u>Sultana Disaster</u> Victim Isaac Dunafin

Hicksville News Jan. 20, 1887

Though the Grand Army of the Republic was not or-

ganized until after the end of the Civil War, the plan was conceived during the war by Dr. Stephenson and a comrade, to organize fraternal groups of veterans. Dr. Stephenson's first post of 43 members had grown [by 1887] to 8,000 posts with a membership of 350,000.

"Hicksville, and the surrounding country, is honored to have a number of surviving veterans of the war, and it was deemed fitting and proper to organize a post.

"A charter was received and an organization effected April 1, 1881. Grand Army posts are named in honor of deceased soldiers, and it was deemed truly appropriate by the soldiers to name the Hicksville post in honor of the man who was dear to every member of the Old Twenty-First, dear to all who knew him, a true man and a true soldier, Capt. Isaac Dunafin. The post was organized under the name "I. Dunafin Post, No. 52 G.A.R."

"Isaac Donafin of Company E 21st OVI was taken prisoner at the battle of Chickamauga. He endured hardship and horrors of Andersonville and other prison pens. At the end of the war he was paroled and was to have been returned to his family and friends. However, he met his death when the fated *Sultana* exploded and sank in the Mississippi River near Memphis, Tennessee.

"The post was organized with 28 chapter members. Their first officers were Commander Johnson O. Foot, S. V. C.- I. E. Kintigh, J. V.C.- T. C. Kinmont, Chaplain - E. E. Hale, Adjt.- J. O. Rose, Q. M. - S. Moore, O. D. - W. J. Henry, O. G. - L. Ferris, Sergt. - Dr. W. D. Otis, Post Inspector - G. Flint, Sergt. Major - Jas. H. Bevington, Q. M. Sergt. - Geo. R. Brown.

"The commanders of the post since its organization [up to 1887] are Johnson O. Foot, Capt. W. J. Henry,

"The officers during 1887 were Commander W. J. Henry, S.V. - Nathan Fuller, J. V. G. - H. Brush, Chaplain - T. T. Armstrong, Q. M. - A.Maxwell, O. D. - John Meek, and O. G. - Daub.

<u>Medal of Honor Winner Asa Hagerty Buried in Defiance</u>

Civil War Medal Recipient

Asel Hagert (also known as Asa Hagerty) was an American soldier who fought in the Civil War. Hagerty received the country's highest award for bravery during combat, the Congressional Medal of Honor. Hagerty's medal was given for his capturing the flag of the Confederate Army of Virginia at the Battle of Sayler's Creek, Virginia, on April 6, 1865. He was honored with the award on May 10, 1865.

Hagerty was born in Canada. He joined the Army from Watertown, New York in August 1864 having been paid \$300 to substitute in the service for another New York resident. He mustered out with his regiment in July 1865.

Asa W. Hagerty and his wife, Mary Louisa, are buried in Section 25, lot 22 of Riverside Cemetery in Defiance. In 1997 a monument was placed by the Defiance County Veterans Office to commemorate his exploits and the honor of the medal.

The President of the United States of America, in the name of Congress, takes pleasure in presenting the Medal of Honor to Private Asel Hagerty, United States Army, for extraordinary heroism on 6 April 1865, while serving with Company A, 61st New York Infantry, in action at Deatonsville (Sailor's Creek), Virginia, for capture of flag.

If you are not familiar with how to access the DPLS catalog, an easy way is to Google "Defiance Public Library System" or go to

<www.defiancelibrary.org>. To see what is in the genealogy collection, use the search engine and enter "Defiance County genealogy".

Some of the research items you may find are histories of area families which have been submitted to the library and books which have been published by our chapter which contain birth, death, marriage, naturalization, early voter registration, and tombstone inscription records.

There also is an Index to Defiance County Probate Court records, 1845 - June 1995. On microfilm are civil and criminal court cases beginning in 1836 and going through May 1847. The Defiance County Records Center has compiled a book of coroner's inquests, taken from files at the Records Center: dates, approximately 1874-1948. These are just a few of the items. Browsing the DPLS catalog, you may find just the resource needed to uncover unique family information!

volunteers. One can access the site without becoming a members and can research by a deceased name, cemetery name, or state. To enter monument photos, one must register as a member which is free. She then explained what is needed in order to become a member. Mary also demonstrated how much information can be entered in addition to the basic photos of the tombstones and related cemetery information.

It was cautioned that, obviously although there are millions of entries, not all tombstones have been photographed and that a deceased person may be buried at a certain site but there is no marker or the monument is no longer legible.

December

Board Meeting December 17

Dianne Kline noted that the chapter blog site has had over 2400 visits.

The board voted to donate \$100 toward Auglaize Villages' purchase of inscribed cups in celebration of the 50th anniversary of its founding.

Michelle Eppel and Marilyn Hite of the Defiance Public Library System were present to discuss items of interest to the chapter. The library is applying for a National Endowment grant which would allow for more digitalization of records. The library is proposing that the newspapers from 1836 to 1922 be digitalized. The question was raised if the money the chapter had targeted for a new microfilm reader might better be used toward digitalization of records. Micelle revealed that the Building Doctor is working with Historic Homes of Defiance to present a two-day program dealing with the restoration and maintenance of historic buildings. Buildings within a five-mile radius of Defiance could apply for on-site consultations.

The Defiance Public Library building is undergoing another stage of restoration and remodeling in 2016. This will include the genealogy/local history room. The library continues to add obituaries to the Hayes Obituary collection-- with volunteers still needed. The adult services staff are all becoming familiar with the genealogy and local history collections, and the needs are still being studied. The listing of family histories donated to the library is being updated online as new histories are received.
